- I. Call to Order
  - A. The meeting of the Fulton County Board of Health was called to order by BOH Chairman, Jack Hardin who announced it was being held by teleconference due to the ongoing order of public health emergency.
  - B. Mr. Hardin made a motion to amend the agenda to add an item to consider the termination of the ongoing Declaration of public health emergency. This motion carried, and the agenda was modified.
  
- II. Old Business
  - A. Approval of Minutes, Regular Board Meeting of January 26, 2022  
Unanimously approved by Board members.
  
- III. Dr. Paxton described that the Board of Health passed a resolution and declaration of public health emergency in 2020, which included the imposition of other social distancing restrictions and restaurant closures and other methods to contain the spread of COVID-19, but that shortly after the declaration, the Governor's series of Executive Orders preempted the Declaration. At this point, with the low prevalence of COVID locally, Dr. Paxton recommended the dissolution of the 2020 declaration and its restrictions. The Board voted to approve the Resolution Of The Fulton County Board Of Health Dissolving Its Declaration And Ratification Of Public Health Emergency Within Fulton County Due To The Threat And Impact Of The Covid-19 Pandemic And Order Of

Closure Or Modification Of Certain Business Activities Countywide To Minimize Direct Human Contact Issued On March 24, 2020; And For Other Purposes. Old Business
